PH e-payments goal gets boost during ECQ

MANILA – The Bangko Sentral ng Pilipinas' (BSP) program to encourage people to use digital payment platforms got a boost during the ongoing enhanced community quarantine (ECQ) in most parts of the country.

Data from the central bank showed that transactions using PESONet and InstaPay visibly increased compared before the ECQ due to restrictions in movement of people outside of their houses.

"To efficiently and safely make payments, the business entities with obligations to pay during this period used EFT (electronic fund transfer) services, particularly, the PESONet," a central bank bulletin showed.



'Cashless' is on the rise.




Telemedicine

Use of digital technologies enable continuity of care for patients and allows healthcare professionals to practice



MMC Telemedicine Implementation

- Trial started in March 2020
- Participants: 150 doctors
- 70% of doctors are using digital payments – via PayMaya and bank transfers
- More than 95% of the doctors said that they will continue to do telemedicine even after ECQ
- Remaining 5% said they will not continue due to limitations in face-to-face engagements requiring in-patient procedures

Patient Telemedicine Guidelines


STEP 1 **DOWNLOAD**  **Zoom** and  **PayMaya** in Android/iOS Device or Computers.
Follow the instructions as you download.

Zoom is an easy-to-use video conferencing, online meeting and messaging application which you can use for teleconsultation with our doctors.

PayMaya is a secure way to process transaction payments after your teleconsultation.

STEP 2 **REGISTER** with  **Zoom** and  **PayMaya**.

• Follow the steps in the application of Zoom and PayMaya.
• For PayMaya, upgrade your account to send and receive payment.


STEP 3 **SCHEDULE** a Video Call (Doctor Teleconsultation) via  **Zoom**.

A CONTACT:
Your doctor or doctor's secretary through SMS or phone call to arrange for a video call (teleconsultation).
OR
MakatiMed On-Call 888-8888 for availability of doctors for teleconsultations.

B SCHEDULE will be made by your doctor or doctor's secretary and a link will be sent to you via SMS or email.

C START the video teleconsultation by clicking on the link that will be sent by your doctor through SMS or email.

D END the video call by selecting on "End" or "Leave" on the screen of your device.

STEP 4 **PAY** the Teleconsultation Fee via  **PayMaya**.

A A payment request from your doctor will be sent to you via SMS with healer name and the amount to pay.

B Click on the SMS link that you received. If you are **already registered** to PayMaya, the link will redirect you to the app where you can fill-out the required details:
- Enter the mobile number of your doctor and the payment amount.
- Under Optional Message field, indicate "Consultation of -patient name-"
* If **not yet registered**, system will require you to download the PayMaya application. It is important to register to PayMaya prior to teleconsultation.

C Review details then click the "Send" button to complete the money transfer.

D You will receive a notification that the transfer is successful.

E All your money transfers will be logged in the "Recent Activities" section of your PayMaya screen.

Qualifications for Teleconsultation
MakatiMed doctors have the discretion to decide whether their patients are qualified for teleconsultation or not. Listed below are the minimum requirements to qualify for MakatiMed teleconsultation:

1. You should have an existing doctor-patient relationship and have seen your doctor in person prior to the teleconsultation.
2. Your condition is not an emergency or that which requires urgent medical intervention or procedure.
3. You do not require any assessment (and/or diagnostic procedure(s)) which can only be performed by the physician at the point-of-care.
4. You can communicate effectively through the communication medium chosen by the physician (e.g. Zoom).

MMC Telemedicine Implementation

- Of the 95% who said they will continue the use of teleconsultation, all of them would want to use an electronic medical records (EMR) that has video conferencing and payment gateway already integrated.
- Makati Med exploring to expand to all consultants with 60% already expressing interest to use telemedicine.
- Main factors to move adoption are ease of use, seamless integration of technologies (clinic appointment system, telehealth, payment)

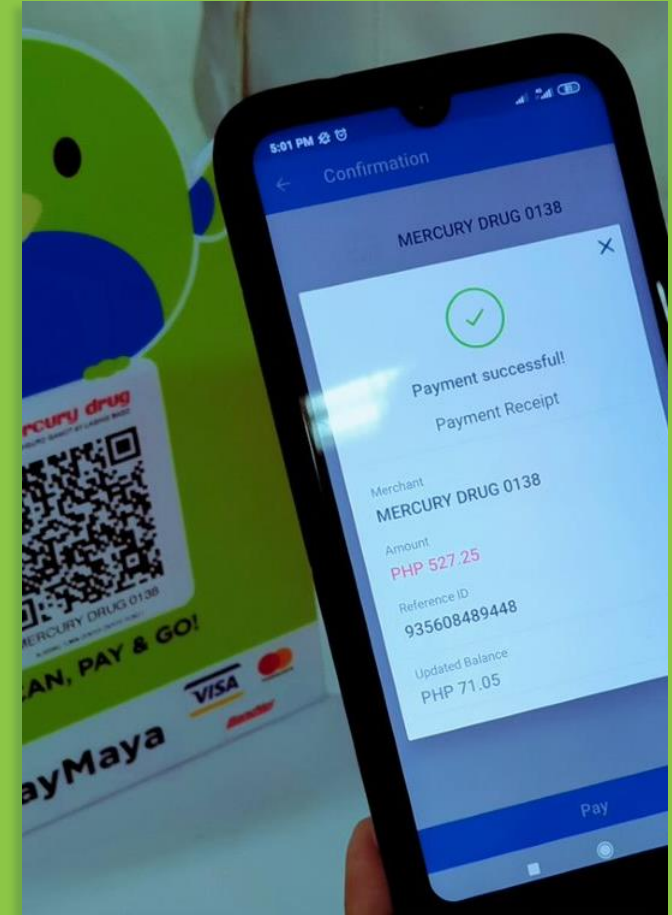
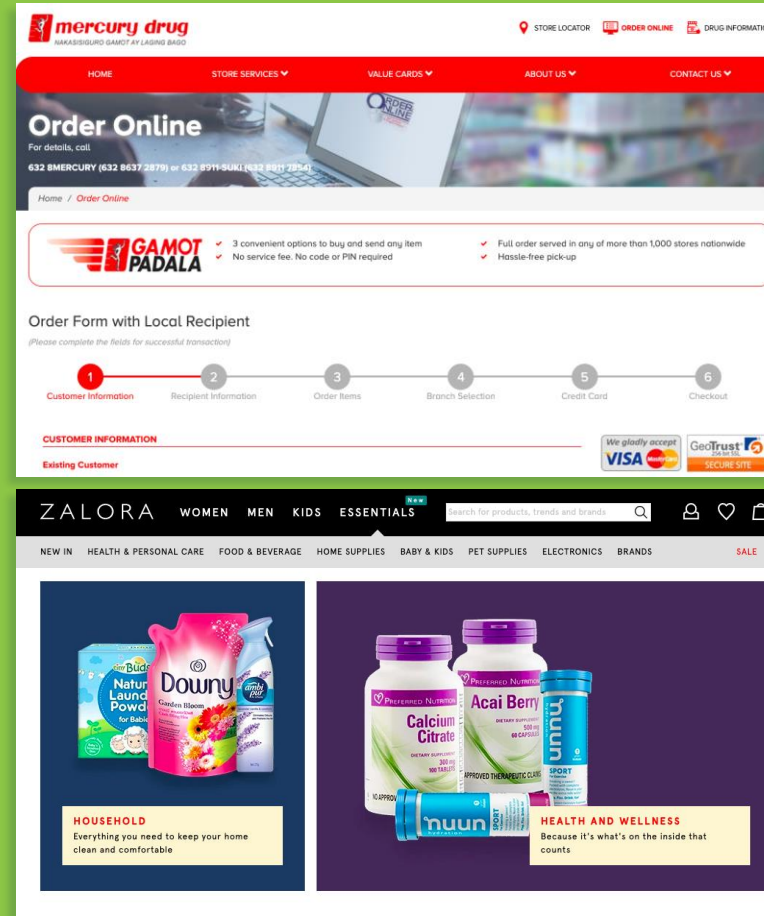

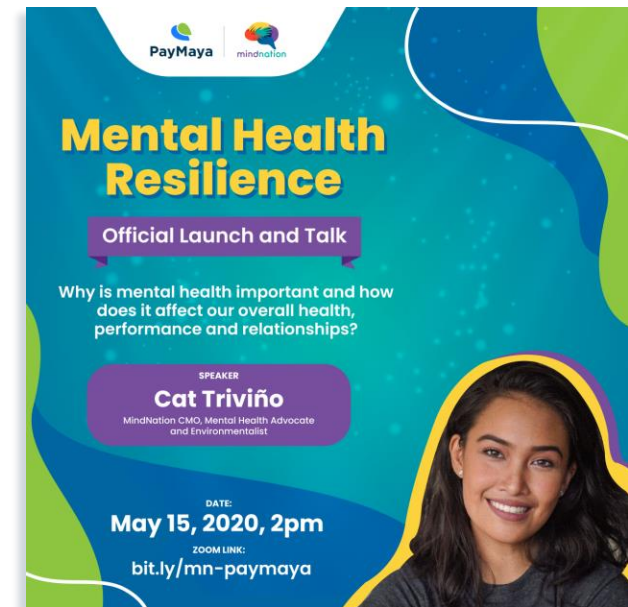

The City of Manila has disbursed more than P13 million in financial assistance to eligible senior citizen beneficiaries through PayMaya.

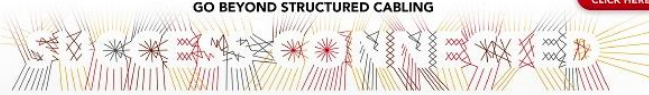
