

# COVID-19 CORRUPTION: KEY RISK TO PHILIPPINE DEMOCRACY AND THE NATIONAL ELECTION OF 2022



We need **responsive governance founded on the principles of transparency and accountability** to surmount the economic and health challenges we face in the wake of the “Wuhan Virus”.

It is with such core principles, and matching institutions to cultivate them, that governments are able to move in cooperation with the various sectors of civil society, creating a culture of responsive public service and a mature democratic system.

# EMERGING RISKS TO PHILIPPINE DEMOCRACY

*"In the health sector, undue influence can lead to misinformation or corruption of information...which can break down a health system's ability to function and have serious implications."*

There is a rising threat of fake news, misinformation campaigns, and misrepresentation in digital spaces. Securing data is **not only a matter of private safety, but a matter of general public security**. These threats must be addressed if we are to move forward to the use of digital tools to facilitate transparency.

Corrosive capital is state-driven and private capital, usually from authoritarian nations, that **that lack accountability and transparency** This makes it especially dangerous for emerging or weakened democracies as it **erodes the strength of the rule of law and enables corrupt practices**.

“But past mistakes should not hamper us from taking bold solutions. **Only with a ‘whole-of-society’ approach can we fight the deadly and invisible enemy.** This crisis is about saving lives, and a rare opportunity to fix our health care system and start a transformation toward good governance.”
